Subject: - Submission of applications under various categories of CBSE affiliation for the session 2025-26 in SARAS 5.0-reg.

Madam/ Sir,

I am inviting your kind attention towards CBSE Circular No. CBSE/AFF./Circular/2024 dated 31.01.2024 related to submission of online application for affiliation of KVs under various categories for the Academic Year, 2025-26. In this regard, the following direction may be given to the concerned Principal of KVs for strict compliance: -

1. To follow the guidelines (manuals) of automated affiliation system given in SARAS Manual 5.0 available on the CBSE website for submission of online application latest by 30.04.2024
2. The KVs which are going to start Class IX and XI in the Academic Year, 2024-25 may apply for CBSE affiliation/upgradation upto Secondary and Senior Secondary level respectively. The KVs where Class IX/XI has been proposed /sanctioned for the next academic year i.e. 2024-25 may also take all necessary efforts for upgradation/affiliation.
3. All necessary documents related to land ownership, Infrastructure details, fire safety certificate and others may be arranged in time for the submission on SARAS Portal.
4. In case of non-availability of any necessary documents in KVs as mandated related to affiliation/upgradation, Principal of concerned KVs may be directed to coordinate with concerned agency/office getting the desired documents in time.
5. In case of any issues with enrolment of Class strength and no. of section, CBSE letter dated 14.11.2019 and KVS letter dated 23.11.2023 to CBSE may be referred.

Accordingly, it is also requested to inform to the Principal of concerned KVs to apply for affiliation or upgradation to Secondary/ Senior Secondary Class on the SARAS 5.0 Portal in time to avoid unnecessary correspondence with CBSE by this office.

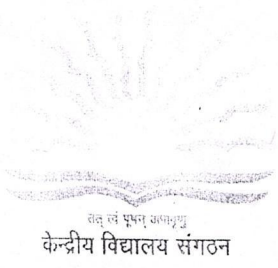

Sub.: - Re-alignment of per section student strength to 40 per section over the next 3 years (i.e. Session 2023-24,-2024-2025 & 2025-2026) - reg.

Sir,

Inviting your kind attention to CBSE Circular No. CBSE/CE/CIRCULAR/2023 dated 02.08.2023, it is to state that the same has been examined at KVS (HQs) level and the relaxation may be given to the KVs in respect of class strength to 40 per section over the next 3 years (i.e. Session 2023-24,-2024-2025 & 2025-2026) as the already enrolled students have to complete their schooling.

Kendriya Vidyalayas are established with the approval of Cabinet Committee on Economic Affairs (CCEA) after following duly established procedures prescribed by the Govt. of India. The Vidyalayas across the country essentially cater to educational needs of the transferable Govt. employees and therefore, priority is given admission to transferable Govt. employees.

The policy related to admission/ enrollment etc. of the Kendriya Vidyalaya Sangathan has duly been approved by the Board of Governors of KVS & Hon'ble Minister of Education, Govt. of India is the Chairman of its BoG. The strength of maximum class strength has already been relaxed by your office vide letter No. CBSE/DS/Coord/2019/2641 dated 14.11.2019. Further, KVS has already taken initiatives by withdrawing certain special provisions to keep the section strength within the desired limits. However, some special provisions like admission under Single Girl Child, PM Cares, Kashmir Migrants etc. as per direction of Ministry of Education, Govt of India are being granted as per the policy and these are over and above sanctioned section strength.

Accordingly, the prescribed section strength for Classes IX to XII may not be insisted at your end and kindly relaxation may be given to Kendriya Vidyalayas with student strength beyond 40 per section.
